Two data sheets, both relating to council residential property transactions, but with completely different data, data fields, data formatting and data input. Neither has a *UPRN.

The top sheet, 'Payments to Suppliers data' shows the standard format for all such data that Tower Hamlets Council has to publish by law.

Although the Service and Division columns have no data the Directorate column does.

The lower sheet, 'API data' is the response to a

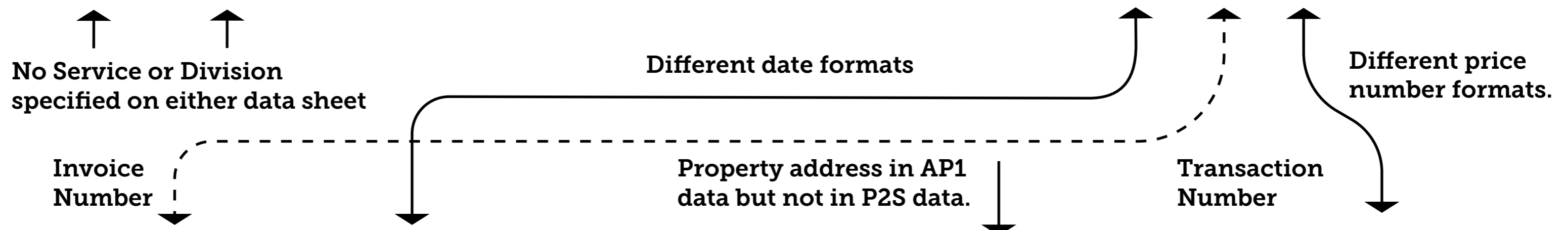
Freedom of Information request concerning the use of the API voucher system.
